4) Found Furnishings is not responsible for lost or damaged items, but we assure that we will do our best to protect and safeguard all items you bring in. Customers are responsible for homeowners or a consignment insurance policy to replace damaged or lost items that are not currently in their possession.

5) The Customer is responsible for picking up items within 14 days of written notice, unless an extension is granted in writing by Found Furnishings. If merchandise is not picked up after 14 days, Found Furnishings will charge a storage fee of 5% of our service charges per day. Any merchandise that is not picked up within 30 days will become the property of Found Furnishings.
